GENERAL MANDATE TO ISSUE NEW SHARES

As at 5 September 2006 (the latest practicable date prior to the printing of this circular) ("Latest Practicable Date"), the issued share capital of the Company comprised 318,000,000 Shares of HK\$0.025 each.

Subject to the passing of Ordinary Resolution No. (5) and on the basis that no further Shares are issued prior to the Annual General Meeting, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 31,800,000 Shares equivalent to 10% of the issued share capital of the Company.

REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and its shareholders for the Directors to have a general authority from Shareholders to enable the Company to repurchase shares in the market. Based on such shareholding and in the event that the Repurchase Mandate is exercised in full, the shareholding of Apex Digital Inc. and David Ji would be increased to 57.72 per cent, and 20.16 per cent of the issued share capital of the Company, respectively and such increase may give rise to an obligation to make a mandatory offer under Rule 26 of the Code.
