1. INTRODUCTION

The purpose of this circular is to provide Shareholders with information in respect of the resolutions to be proposed at the 2015 AGM for (i) the granting of the Issuance Mandate to the Directors; (ii) the granting of the Buyback Mandate to the Directors; (iii) the extension of the Issuance Mandate by adding to it the nominal amount of issued Shares repurchased by the Company under the Buyback Mandate; and (iv) the re-election of the retiring Directors and to provide Shareholders with a notice of such annual general meeting at which the resolutions will be proposed to consider and, if thought fit, approve such matters.

2. PROPOSED GRANTING OF THE ISSUANCE MANDATE AND THE BUYBACK MANDATE

At the annual general meeting of the Company held on 23 September 2014, general mandates were granted to the Directors to exercise the power of the Company to issue new Shares not exceeding 136,657,939 Shares and to repurchase Shares not exceeding 68,328,969 Shares respectively. As at the Latest Practicable Date, 136,657,939 Shares at a subscription price of HK\$0.28 per Share were issued under the said general mandate on 22 April 2015, details of which have been disclosed in the announcements of the Company dated 13 April 2015 and 22 April 2015. The said general mandate to repurchase Shares have not been used since it was granted and it will lapse at the conclusion of the 2015 AGM.

Accordingly, ordinary resolutions will be proposed at the 2015 AGM to approve the granting of new general mandates to the Directors:

- (a) to allot, issue or deal with new Shares of an aggregate nominal amount not exceeding 20% of the total nominal amount of the issued ordinary share capital of the Company as at the date of passing of such resolution (i.e. an aggregate nominal amount of Shares not exceeding HK\$42,398,952.6 (equivalent to 423,989,526 Shares) on the basis that the issued ordinary share capital of the Company remains unchanged as at the date of the 2015 AGM);
- (b) to repurchase Shares on the Stock Exchange of an aggregate nominal amount not exceeding 10% of the total nominal amount of the issued ordinary share capital of the Company as at the date of passing of such resolution (i.e. an aggregate nominal amount of Shares not exceeding HK\$21,199,476.3 (equivalent to 211,994,763 Shares) on the basis that the issued ordinary share capital of the Company remains unchanged as at the date of the 2015 AGM); and
- (c) to extend the Issuance Mandate by an amount representing the aggregate nominal amount of issued Shares repurchased by the Company pursuant to and in accordance with the Buyback Mandate.

The Issuance Mandate and the Buyback Mandate will continue in force until the conclusion of the next annual general meeting of the Company held after the 2015 AGM or any earlier date as referred to in the proposed ordinary resolutions contained in items 9 and 10 of the notice of the 2015 AGM as set out on pages 13 to 16 of this circular. As at the Latest Practicable Date, the Directors have no immediate plan to repurchase any Share or issue any new Share pursuant to the Buyback Mandate and the Issuance Mandate.

An explanatory statement as required by the Listing Rules in connection with the Buyback Mandate is set out in Appendix I to this circular.

3. PROPOSED RE-ELECTION OF THE RETIRING DIRECTORS

Pursuant to Bye-law 86(2), the Board shall have power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy on the Board or, subject to authorization by Shareholders in general meeting, as an addition to the existing Board. Any Director so appointed by the Board shall hold office only until the next following general meeting of the Company (in the case of a Director appointed to fill a casual vacancy) or the next following annual general meeting of the Company (in the case of a Director appointed as an addition to the Board) and shall then be eligible for re-election at that

meeting provided that any Director who so retires shall not be taken into account in determining which particular Directors or the number of Directors who are to retire by rotation at such meeting pursuant to Bye-law 87.

Pursuant to Bye-law 87, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not a multiple of three, the number nearest but not less than one-third) shall retire from office by rotation provided that every Director (including Director(s) appointed for a specific term) shall be subject to retirement by rotation at least once every three years. The Directors to retire by rotation shall include (so far as necessary to ascertain the number of Directors to retire by rotation) any Director who wishes to retire and not to offer himself for re-election. Any further Directors so to retire shall be those of the other Directors subject to retirement by rotation who have been longest in office since their last re-election or appointment. As between persons who became or were last re-elected Directors on the same day, the person(s) to retire shall (unless they otherwise agree among themselves) be determined by lot. A retiring Director shall be eligible for re-election by the Shareholders at the relevant annual general meeting.

According to the above Bye-laws 86(2) and 87, Dr. Li Zhong Yuan, Mr. Zhou Bao Yi and Mr. Chung Ho shall retire by rotation at the 2015 AGM. All retiring Directors, being eligible, will offer themselves for re-election at the 2015 AGM.

Pursuant to Rule 13.74 of the Listing Rules, a listed issuer shall disclose the details required under Rule 13.51(2) of the Listing Rules of any director proposed to be re-elected or proposed new director in the notice or accompanying circular to its shareholders of the relevant general meeting, if such re-election or appointment is subject to shareholders' approval at that relevant general meeting. The requisite details of Dr. Li Zhong Yuan, Mr. Zhou Bao Yi and Mr. Chung Ho are set out in Appendix II to this circular.

4. 2015 AGM

The notice of the 2015 AGM is set out on pages 13 to 16 of this circular. At the 2015 AGM, resolutions will be proposed to approve, inter alia, the granting of the Issuance Mandate and the Buyback Mandate, the extension of the Issuance Mandate by the addition thereto of the nominal amount of Shares repurchased by the Company pursuant to the Buyback Mandate and the re-election of the retiring Directors.

A form of proxy for use at the 2015 AGM is enclosed with this circular and such form of proxy is also published on the websites of the Stock Exchange (www.hkexnews.hk) and the Company (http://chc673.com). Pursuant to Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll (except where the resolution relates purely to a procedural or administrative matter which may be voted on by a show of hands) and accordingly, all resolutions proposed at the 2015 AGM will be taken by poll. To the best of the Directors' knowledge, information and belief, none of the Shareholders is required to abstain from voting on the ordinary resolutions to be proposed at the 2015 AGM pursuant to the Listing Rules and/or the Bye-laws.

5. **RECOMMENDATION**

The Directors consider that the granting of the Issuance Mandate and the Buyback Mandate, the extension of the Issuance Mandate and the re-election of the retiring Directors are in the interests of the Company and the Shareholders as a whole. APPENDIX I EXPLANATORY STATEMENT ON THE BUYBACK MANDATE

The following is an explanatory statement required by the Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the 2015 AGM in relation to the granting of the Buyback Mandate.

1. REASONS FOR BUYBACK OF SHARES

The Directors believe that the granting of the Buyback Mandate is in the interests of the Company and the Shareholders. Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share. The Directors are seeking the granting of the Buyback Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

2. SHARE CAPITAL

As at the Latest Practicable Date, the issued ordinary share capital of the Company comprised 2,119,947,634 Shares.

Subject to the passing of the ordinary resolution set out in item 10 of the notice of the 2015 AGM in respect of the granting of the Buyback Mandate and on the basis that the issued ordinary share capital of the Company remains unchanged on the date of the 2015 AGM, the Directors would be authorized under the Buyback Mandate to repurchase, during the period in which the Buyback Mandate remains in force, an aggregate nominal amount of Shares up to HK\$21,199,476.3 (equivalent to 211,994,763 Shares), representing 10% of the aggregate nominal amount of the issued ordinary Shares as at the date of the 2015 AGM.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its Memorandum of Association and Bye-laws, the laws of Bermuda and/or any other applicable laws, as the case may be.

The Company is empowered by its Memorandum of Association and the Bye-laws to repurchase Shares. The laws of Bermuda provide that the amount of capital paid in connection with a share repurchase by a company may only be paid out of the capital paid up on the relevant shares, or funds of the company which would otherwise be available for dividend or distribution or out of the proceeds of a fresh issue of shares made for such purpose. The amount of premium payable on a repurchase may only be paid out of the funds of the company which would otherwise be available for dividend or distribution or out of the share premium account of the company.

APPENDIX I EXPLANATORY STATEMENT ON THE BUYBACK MANDATE

4. IMPACT OF REPURCHASES

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 March 2015) in the event that the Buyback Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Buyback Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital or the gearing levels of the Company.

5. TAKEOVERS CODE

If a shareholder's proportionate interest in the voting rights of the Company increases as a result of the Directors exercising the powers of the Company to repurchase Shares pursuant to the Buyback Mandate, such increase will be treated as an acquisition of voting rights for the purpose of Rule 32 of the Takeovers Code.

As far as the Directors are aware, as at the Latest Practicable Date, Speedy Brilliant Investments Limited, which is beneficially owned by Mr. Zhou Disun, held 376,510,000 Shares (representing 17.76% of the total issued Shares) and Mr. Ying Wei, held 272,000,000 Shares (representing 12.83% of the total issued Shares). Save as disclosed above, there were no other Shareholders holding 10% or more in the issued Shares. The Directors are not aware of any consequences which will arise under the Takeovers Code as a result of any repurchase to be made under the Buyback Mandate.

6. GENERAL

None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their respective close associates have any present intention to sell any Share to the Company in the event that the granting of the Buyback Mandate is approved by the Shareholders.

The Company has not been notified by any core connected persons of the Company that they have a present intention to sell any Share to the Company, or that they have undertaken not to sell any Share held by them to the Company in the event that the granting of the Buyback Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases of Shares pursuant to the Buyback Mandate in accordance with the Listing Rules and the applicable laws of Bermuda.

APPENDIX II DETAILS OF THE RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED AT THE 2015 AGM

1. DR. LI ZHONG YUAN

Dr. Li Zhong Yuan, aged 53, was appointed as the executive Director on 27 November 2000. He is also a director of certain subsidiaries of the Company. Dr. Li received his Ph.D. in Mathematics from the University of Michigan at Ann Arbor, the USA and subsequently worked as an Assistant Professor of Mathematics at the Massachusetts Institute of Technology, the USA ("MIT"), where he was consecutively awarded research grants from the National Science Foundation. After MIT, he held senior positions with a number of major international investment banks, including Bankers Trust Company, Salomon Brothers and IBJ Asia Limited and has extensive experience in capital raising and risk management. In late 1996, he was in charge of building up capital markets and derivative businesses in multi-asset classes in Northern Asia and was a director of Rabobank International before setting up a financial and technology investment firm. Save as disclosed above, Dr. Li has not held any other directorship in listed companies in the last three years.

Dr. Li has entered into a service contract with the Company with effect from 1 September 2009 for a term of first two years which cannot be terminated unless agreed by both the Company and Dr. Li and with automatic renewals unless terminated by not less than six months' notice in writing served by Dr. Li or the Company or superseded by a new service contract after expiry of the first two years as aforesaid. The salaries and other benefits of Dr. Li amounted to HK\$2,289,000 for the year ended 31 March 2015, which was determined by the Board with reference to his responsibilities. He is subject to retirement and reelection in accordance with the Bye-laws. The provisions of the Bye-laws in respect of directors' retirement and re-election are set out in paragraph 3 of the Letter from the Board in this circular.

As far as the Directors are aware, (1) Dr. Li does not have any relationship with any of the other Directors, senior management, substantial Shareholders (as defined in the Listing Rules), or controlling Shareholders (as defined in the Listing Rules) of the Company; and (2) as at the Latest Practicable Date, Dr. Li had the following interests in the issued/underlying Shares pursuant to Part XV of the SFO:

- (i) He was deemed to be interested in 18,779,000 issued Shares, representing approximately 0.89% of the issued Shares, which were held by Timenew Limited, a company wholly owned by Dr. Li; and
- (ii) He held 2,619,000 share options granted by the Company, which entitled him to subscribe for 2,619,000 Shares, representing approximately 0.12% of the issued Shares.

Save as disclosed above, Dr. Li was not interested or deemed to be interested in any Shares or underlying Shares pursuant to Part XV of the SFO. 2. MR. ZHOU BAO YI

He is the president of Vision Holding Technology Co. Ltd. Mr. Zhou received his Master degree in Economics from People's University, PRC and is a certified Senior Accountant in the PRC. Save as disclosed above, Mr. Zhou has not held any other directorship in listed companies in the last three years.

Save as disclosed above, Mr. Zhou was not interested or deemed to be interested in any Shares or underlying Shares pursuant to Part XV of the SFO.

There is no information which is discloseable nor is/was Mr. Zhou involved in any of the matters required to be disclosed pursuant to any of the requirements under paragraphs 13.51(2)(h) to 13.51(2)(v) of the Listing Rules and there are no other matters concerning Mr. Zhou that need to be brought to the attention of the Shareholders.

APPENDIX II DETAILS OF THE RETIRING DIRECTORS PROPOSED TO BE RE-ELECTED AT THE 2015 AGM

3. MR. CHUNG HO

Mr. Chung Ho, aged 52, was appointed as the executive Director on 28 December 2012. He graduated from Shanghai Railway University with a Bachelor degree in Science and Technology and from the Central University of Finance and Economics with a Master degree in Economics. He has over 20 years of experience in investment, financing, corporate management and other areas and has worked in several investment institutions and companies in Mainland China and Hong Kong as senior manager and director. Mr. Chung has entered into a service contract with the Company with effect from 30 December 2014 for a term of two years unless terminated by six months' notice in writing served by Mr. Chung or the Company. The salaries and other benefits of Mr. Chung amounted to approximately HK\$450,000 for the year ended 31 March 2015, which was determined by the Board with reference to his responsibilities. He is subject to retirement and re-election in accordance with the Bye-laws. The provisions of the Bye-laws in respect of directors' retirement and re-election are set out in paragraph 3 of the Letter from the Board in this circular.
